The Promoter

1. The Promoter is Samsung Electronics (UK) Limited, Samsung House, 2000 Hillswood Drive, Chertsey, Surrey, KT16 ORS (the "**Promoter**").

Promotion Period

2. The Promotion will commence at 00:01 (GMT) on the 15th April 2024 and close at 23:59 (GMT) on the 31st December 2024 (the "**Promotion Period**").

Eligibility

- To be eligible to participate in the Promotion you must be a business operating and registered in the United Kingdom, Isle of Man, Channel Islands or Republic of Ireland ("Participant"). Educational institutions (schools and universities) will also be eligible to participate in the Promotion.

- 3. Purchases from auction websites (e.g. eBay) or marketplace sales through retail websites (e.g. Amazon Marketplace or Play Trade) are specifically excluded from this Promotion.
- 6. For your existing Trade-In Device to qualify for the Reward it must be a PC (notebook, laptop, desktop, or workstation) that meets the following criteria (the **"Trade-In Criteria"**):
 - a. Not older than 5 years;
 - b. In good working condition (reasonable wear and tear shall be acceptable);

Claims

- 4. For over 10 Trade In Devices sent from the UK, the MyDHL API must be used to self-generate a DHL label. ROI participants will also receive instructions to self-generate a DHL label.
