Outbound Calling

Customer shall advise every end user both new and existing prominently and in plain language of the circumstances under which the Outbound Calling feature may not be available through or may be in some way limited by comparison to traditional emergency service

Such circumstances include but are not limited to relocation of the end user's IP compatible CPE (customer premises equipment) use by the end user of a non-native telephone number broadband connection failure loss of electrical power and delays

that may occur in making a Registered Location available in or through the ALI database.

Customer shall obtain and keep a record of affirmative acknowledgement by every end-user of having received and understood the limitations of Customer's service which uses the Outbound Calling feature.

Customer should provide end-users one or more methods of updating their registered location. Any method used must allow end-user to update the registered location at will and in a timely manner.

In the event of a validation of the address's failure the errors in end-users records shall in no event be corrected in real-time.

The primary method of routing of emergency calls is not available for the entire territories of United States; therefore, a second routing solution is used according to the applicable regulatory framework which may cause the following limitations:

- 1. when the end-user places the emergency call this may be routed to an Emergency Services Center other than the Emergency Services Center that would normally receive the emergency call placed from the end-user location;
- 2. the end-user physical location and CLI will not be presented to the Emergency Services Centers; 3. in the event that the end-user cannot speak no information will be provided to the Emergency Services Centers in order to contact Onecom to obtain information that could allow them to dispatch emergency services to the end-user's location.

United States Vox800 numbers are reachable from US mainland (48 states). Canadian Vox800 numbers have extended reachability covering US mainland and Canada.

Puerto Rican Vox800 numbers have extended reachability covering US mainland Canada Hawaii and Puerto Rico. Virgin Islands Vox800 numbers have extended reachability covering US mainland Alaska Canada Hawaii Puerto Rico Guam Mariana Islands (Saipan) and Virgin Islands.

Outbound Calling National currently does not support outbound calling to Premium rate numbers and temporally to N11 short codes excluding 911

Legal or regulatory requirement

Address or identification requirements

Geographic numbers require an address proof of address and proof of ID before activation of the number. In addition the nationality and passport number or ID card number of the end user is required and for business end users the business registration number should be given. For end users a copy of the ID card or passport. For business end users a copy of the ID or passport of its legal representative. The proof of address will be an objective document showing a link between user and address. The address location of the end user must be in the city corresponding to the area code of the activated number.

National numbers require an address proof of address and proof of ID before activation of the number. In addition the nationality and passport number or ID card number of the end user is required and for business end users the business registration number should be given. For end users a copy of the ID card or passport. For business end users a copy of the ID or passport of its legal representative. The proof of address will be an objective document showing a link between user and address. The address location of the end user can be anywhere globally.

Reachability limitations
